

# OCP SENIOR CREDIT FUND

Monthly Update as at January 31, 2012



## Investment Rationale and Objectives

OCP Senior Credit Fund provides Unitholders with exposure to the performance of an actively managed, diversified portfolio comprised primarily of first lien floating rate senior secured loans of non-investment grade North American issuers.

The Fund's objectives are: (i) provide Unitholders with attractive, quarterly, tax-advantaged distributions, currently targeted to be \$0.50 per annum, representing an annual yield of 5% based on the original issue price of \$10.00 per Unit; (ii) preserve capital; and (iii) generate enhanced returns through increasing cash flow to the portfolio as interest rates rise.

## Commentary

Net performance of OCP Senior Credit Fund was 3.57% in January. Markets moved steadily higher in the month encouraged by positive U.S. economic news regarding GDP growth, employment and retail sales. The CS Leveraged Loan Index, CS High Yield Bond Index, and S&P500 returned 2.00%, 2.66%, and 4.48% in the month, respectively.

Capital appreciation was the primary driver of the Portfolio's gain with only one of its 55 issuers experiencing a mark-to-market loss in the month. The Fund's NAV has benefitted from investors refocusing on credit fundamentals versus macroeconomic and technical issues.

The outlook for the senior secured loan asset class remains positive and the loan market default rate is expected to remain below its historic average level with estimates from JP Morgan and Credit Suisse in the 1-2% range for 2012 and 2013. There continued to be no defaults in the Portfolio.
