Investment Rationale and Objectives

OCP Senior Credit Fund provides Unitholders with exposure to the performance of an actively managed, diversified portfolio comprised primarily of first lien floating rate senior secured loans of non-investment grade North American issuers.

The Fund's objectives are: (i) provide Unitholders with attractive, quarterly, tax-advantaged distributions, currently targeted to be \$0.50 per annum, representing an annual yield of 5% based on the original issue price of \$10.00 per Unit; (ii) preserve capital; and (iii) generate enhanced returns through increasing cash flow to the portfolio as interest rates rise.

Commentary

Net performance of OCP Senior Credit Fund was 0.81% and 8.83% in November and year-to-date, respectively. Risk assets continued to move higher in the month even as expectations around the timing of the Federal Reserve's tapering continued to evolve and Treasury bond prices remained volatile. The CS Leveraged Loan Index, CS High Yield Index, and S&P500 returned 0.48%, 0.39%, and 3.05% in the month, respectively.

The Portfolio's top performers in November included senior secured loans of Avaya, Brand Energy, and SRA International. Avaya's loans traded higher following the release of strong fourth quarter results with stronger than expected revenues and progress on cost control initiatives. Avaya has strong liquidity and minimal near term maturities. There were no significant detractors during the month and there continued to be no defaults in the Portfolio.
