Investment Rationale and Objectives

OCP Senior Credit Fund provides Unitholders with exposure to the performance of an actively managed, diversified portfolio comprised primarily of first lien floating rate senior secured loans of non-investment grade North American issuers.

The Fund's objectives are: (i) provide Unitholders with attractive, quarterly, tax-advantaged distributions, currently targeted to be \$0.50 per annum, representing an annual yield of 5% based on the original issue price of \$10.00 per Unit; (ii) preserve capital; and (iii) generate enhanced returns through increasing cash flow to the portfolio as interest rates rise.

Commentary

Net performance of OCP Senior Credit Fund was 1.07% in January. The positive sentiment in certain markets at the end of 2013 reversed on reports of slower than expected U.S. economic growth in the month and mounting stress in emerging markets. U.S. non-investment grade credit outperformed equities; the CS Leveraged Loan Index and CS High Yield Index returned 0.71% and 0.76%, respectively, while the S&P500 returned (3.46%).

The vast majority of the Fund's positions gained in the month with interest income and price appreciation making roughly equal contributions to the positive performance. The largest detractor from performance during the month represented less than 1 basis point of the NAV. There continued to be no defaults in the portfolio.
